

ACCOMMODATION BOOKING & CANCELLATION POLICY

Version: March, 2024

1. RESERVATION PROCESS

The Organizing Committee (OC) will guarantee accommodation for all participants approved at the FISU OAS System by the end of the Individual Entry Form submission stage.

The official period of stay in the city of Rio de Janeiro starts on the 30th of August, at 02:00 PM, and finishes on the 10th of September, at 12:00 PM.

The length of stay of each participant will be calculated according to the arrival and departure information available in the FISU OAS Travel Form. In case of different check-in and/or check-out dates, the actual period of stay should be informed to the OC with no less than 30 days before the beginning of the event.

For each participant, including extra officials, the Participation Fee per person per night is 80 EUR. Additional reservations should be requested in advance to the OC and will be subject of availability.

2. CANCELLATION POLICY

A full refund of the Participation Fee will be made for cancellations informed until 30 days before the beginning of the competition.

In case there is any no-show or cancellation/amendment of the delegation, in part or full, within 30 days or less from the beginning of the competition, 100% of the Participation Fee will be charged.

Special cases such as injury, visas denied, flight cancellation/delay and others should be immediately informed to the OC, which will take all possible measures to minimize eventual losses.

3. CHECK-IN AND CHECK-OUT INFO

Check-in time is 02:00 PM.

Check-out time is 12:00 PM.

In any case, no early check-in or late check-out requests are available. Additional daily room rates will be charged for participants with arrival scheduled before 8:00 AM and/or departure after 03:00 PM.

4. PAYMENT AND BILLING

Each participant is responsible for additional costs caused by extra services acquired during his/her stay. Payment must be made by the participant or responsible at check-out, following the hotel rules.

5. OCCUPANCY AND GUEST POLICY

The maximum occupancy for each room is the following:

Room Type	Maximum Occupancy
Single	01
Double	02
Triple	03

Visitors are allowed to access the common premises of the hotel. Entry in the room area is only permitted to hotel guests.

6. SMOKING AND PETS

All rooms are non-smoking. Smoking is only allowed in designated smoking areas.

No pets are allowed in the premises of the hotel.

7. DAMAGES AND LIABILITIES

Guests are responsible for any damages caused to the room or hotel property during their stay.

The hotel is not liable for any loss or theft of personal belongings.

8. NOISE AND BEHAVIOR

Guests are expected to respect the quiet enjoyment of other guests.

Excessive noise or disruptive behavior may result in eviction without a refund.

9. SAFETY AND SECURITY

Guests should adhere to all safety and security guidelines the hotel provides.

The hotel is not responsible for any accidents, injuries, or losses that occur on its premises.
