FINANCIAL REGULATION General points



• The regulation aims to define the financial rules set up by the organizing committee for the welcoming of the accredited delegations during the World University Championship Rugby Sevens 2024.

• Any exception to the regulations set out below must be agreed in writing by the organizing committee.



FINANCIAL REGULATION Registration



- D 6 months : registration without deposit
- D 5 months : registration with the payment of a 5 000€ deposit to the FISU
- D -1 month :
 - o 100% of the balance to the organizer upon receipt of the invoice
 - o Costs for referees and international judges balanced between the NUSF
 - o 2000€ of caution per team to repair possible damages caused during the stay



FINANCIAL REGULATION Billing



- The invoice for the 5000€ deposit paid to the FISU 5 months before the event is issued by the FISU and can be found in each NUSF's personal extranet space.
- Invoices will be issued by the organizing committee in euros in accordance with French financial regulations.
- Any cancellation made by a NUSF after the payment of the deposit to the FISU will result in the loss of the 5 000€ paid (see FISU regulations)



FINANCIAL REGULATION Payment



• All payments must be made to the organizing committee by bank transfer upon receipt of the invoice.

The NUSF will bear the bank transfer fees.

FINANCIAL REGULATION Standard package



The organizing committe will receive a daily participation fee* for each member of the accredited delegation, in accordance with the different population quotas.

- Standard package: 80 € / day / participant within a limit of 16 participants in each team for standard prestations, must be paid by bank transfer before the arrival day:
 - o 8 twin rooms
 - o 1 single room during the competition (from the 7th to the 13th of June 2024)

FINANCIAL REGULATION Special package



Outside the conditions set by the standard package, the following special package* applies.

- Special package : 160 € / day / participant for special services (subject to availability), must be paid by bank transfer before the arrival day :
 - o Additional participant (NF Official or addition to the quotas specified in the FISU General Regulations for World University Championship)
 - o Additional day (outside the competition period from the 7th to the 13th of June)
 - Additional single room (subject to availability)

FINANCIAL REGULATION Referee fees



In accordance with the FISU's rules, the following costs for referees and international judges will be balanced between the NUSF:

- A 50€ per diem for each referee and international judge appointed by World Rugby
- Costs of the stay for the entire competition
- Travelling costs from their home country to the competition
